SCHOOLYARD POLICY

Our schoolyard is a safe and welcoming space for everyone. To help ensure this, all parents and guardians are expected to support the admission and dismissal process by waiting at the appointed locations until students are admitted to the building and/or dismissed by their teachers. Please allow for all students to enter and exit the building safely. Please also note that no pets, specifically dogs, are allowed on school property at any time as this is a major safety concern.

PLAYGROUND POLICY

We are excited to utilize the playground that was provided to us by the Philadelphia Eagles. Please adhere to the following playground rules and expectations:

- The playground is to be utilized by students only.
- Students are permitted to use the playground at the discretion of the school team. The playground is not open in the morning at admission. The playground will close promptly at 3:35 PM at the close of the school day.
- The school team has the right to open and close the playground as needed.
- The playground is always closed during inclement weather (rain, snow, etc.)
- All students must be supervised while using the playground. School staff is responsible
 only during the school day when permission is given. Parents are responsible for their
 children if they permit them to use the playground during dismissal.
- Students are required to use the equipment properly (i.e. sliding down the slide, not walking up, etc.).

VISITOR POLICY

Parents and guardians are encouraged to visit schools and meet with teachers and administrators about their child's progress. Visitors to Lawton must present themselves to the school office or have standing permission from the principal. To provide safe and orderly learning environments, each visitor to public school buildings or grounds must receive authorization from the school principal or his/her designee.

Community and Parent Volunteers in our School:

ATTENDANCE AND TRUANCY

School officially begins at 9:00 a.m. The gates will open at 9:00 a.m. to begin admission/supervision and students will have until 9:10 to get to their classroom. Your child will be marked late if they arrive after that time. Breakfast will be provided to all students as they enter and will be eaten in class.

Dismissal will begin at 3:20 p.m. for Special Education programs. Grades K through 5 will be dismissed at 3:30 p.m. daily. *Please note that Kindergarten will dismiss students at 12:30 the first five days of school; Monday, August 25, 2025 through Friday, August 29, 2025.* On these days, Kindergarten students will dismiss through the "B" door on Lardner St.

All students will be dismissed from the doors that they enter from (see above). Please be sure that all pick up information is current by advising teachers and the Main Office of any changes.

Please ensure that all child care agencies are fully aware of dismissal times, procedures and expectations.

All students should be picked up promptly by 3:30 PM. Any family that does not adhere to the pick up time will be required to meet with the principal to discuss further actions.

In alignment with the School District of Philadelphia Policy, all absence notes need to be submitted within 3 days of the student returning to school. Coming to school every day is extremely important for all students. As a reminder, students in Philadelphia are expected to be in school for a minimum of 95% of the time. That means that your child cannot miss more than 8 days of school per school year. Both excessive absences and latenesses can result in a truancy/DHS referral. EMERGENCY EVACUATIONS

- Our alternate school site in case of emergency is Harding Middle School, located at 2000 Wakeling Street.
- Notifications will be made if emergency relocation is necessary

CONTACT INFORMATION

- Please update us ASAP if you have a change in contact information
 - o Complete the form attached or call the main office

USE OF ELECTRONIC DEVICES

- o 1st Offense: Staff confiscates device and returns to student at end of day
- o 2nd Offense: Staff confiscates device and parent must retrieve it from office
- o 3rd Offense: Staff confiscates device and parent conference is held to determine next steps

REPORT CARDS AND CONFERENCES

- Attending report card conferences allows teachers and parents to communicate.
- Report cards will be issued FOUR times a year, in November, January, March and June.

SCHOOL HEALTH SERVICES

- School Health Services provides a variety of services to students: screening for healthy development, special programs and assistance with referrals.
- In addition to requirements, our school nurse also provides care for students who become sick or who are injured at school.
 - o The school nurse will contact parents in the event of an emergency or if follow-up care by the student's primary care/outside provider is needed.
- School District Requirements:
 - o Immunizations—No student will be admitted to school without documentation of proper immunizations.
 - o Physical examinations are required by state law when the student enters school, sixth grade and ninth grade. Parents are encouraged to take their child to their primary care physician for these examinations.
 - o Medication Policy—A student receiving medication in school must first have written approval from the student's physician, the school nurse and School Health Services. No student will be permitted to take medication in school without this approval. If at all possible, medication should be given at home only. For example, antibiotics three times a day can be taken before school, immediately after school and at bedtime.

COUNSELING AND SOCIAL WORK SERVICES

• Families are invited to contact our certified counselor, Ms. Nicketia Bender (215) 400-3340 or via ClassDojo to discuss their child's academic, personal, and social growth which may potentially affect their child's success in school.

BIRTHDAYS AND SCHOOL CELEBRATIONS

• Students and teachers will have the opportunity for celebrations throughout the school year, however, birthday celebrations (with food) are not permitted as we do not have enough instructional time to facilitate such events. As birthdays are important, teachers/school staff are happy to acknowledge every students' birthday.

STUDENT BEHAVIOR

- Students need a safe, positive environment in order to learn.
- Providing a safe environment is our number one priority.
- Our discipline policies are designed to create a safe, positive environment for all students.

SCHOOL NORMS (RULES)

- We have broad, school-wide rules that govern the way we expect students to behave:
 - o We are Safe
 - o We are Responsible
 - o We are Respectful

FOCUSING ON THE POSITIVE

- When students follow rules "above and beyond" our expectations, they earn "PBIS Points"
 - o PBIS Points can be earned for displaying our school values, attendance, and uniform adherence
 - o PBIS points are used to determine participation in PBIS Events
 - o Students can also spend PBIS points at the "school store,"


CONSEQUENCES

- Consequences are designed to encourage students to follow the rules.
- Consequences do not fix the problems a student has caused when they break a rule.
- Our consequences are progressive and will be applied appropriately as required.
 - o Such consequences may include loss of privileges and/or participation in school-wide or grade-level activities (5th Grade Dance) and events, detention, alternative class assignment, team interventions, In-School suspension, (financial/physical) replacement of lost/damaged property.
